## DAILY CARE INSTRUCTIONS FOR STORE PERSONNEL

1. CHECK ALL COMPONENTS. BE SURE TO CHECK FOR LOOSE BOLTS OR NUTS. REPLACE ANY BROKEN OR WORN PARTS.
2. CHECK ALL WARNING LABELS. REPLACE IF MISSING, WORN OR ILLEGIBLE.
3. CHECK BASKET FOR WORN AREAS THAT MAY CAUSE INJURY TO SHOPPER.
4. REPLACE RUSTED OR WORN PARTS.
5. CHAINS MUST BE CHECKED FOR WORN OR BROKEN PARTS.

## DIRECTIONS

1. SECURE WHEELCHAIR BRAKES.
2. GUIDE EACH RED FORK TO A CONVENIENT PLACE ON THE CHAIR'S FRAME.
3. WRAP CHAIN AROUND FRAME AND UNDER FORK.
4. SLIDE A CHAIN LINK INTO BAR'S GROOVE TO ATTACH.
5. ENSURE WHEELCHAIR AND HANDY CART ARE SECURELY ATTACHED BEFORE USE.

## INSTRUCCIONES

1. ACTIVA EL FRENO DE LA SILLA DE RUEDAS.
2. GUÍA CADA HORQUILLA ROJA AL LUGAR APROPIADO DE LA SIELLA DE RUEDAS.
3. ENVUELVE LA CADENA ALREDEDOR DEL MARCO DE LA SILLA Y DEBAJO DE LA HORQUILLA.
4. DESLICE LA CADENA EN LA RANURA DE LA BARRA PARA CONECTAR.
5. COMPRUEBA QUE LA SILLA DE RUEDA Y HANDY CART ESTÁN BIEN SUJETOS ANTES DE SU USO.

## **ATTACHMENT PROCEDURE**

The Handy Cart can be attached to any personal or store's wheelchair.



*1. Secure wheelchair brake.*



*2. Guide bar to wheelchair frame for best connection.*



*3. Fork is now placed snugly next to chair's frame.*



*4. Wrap chain tightly under the fork and around frame. Slide a link into bar's groove to attach.*



*5. Ensure wheelchair and Handy Cart are securely attached before use.*



*6. Shopper is ready to go!*
